

# Simplii Financial GLOBAL MONEY TRANSFER<sup>TM</sup> REFERRAL PROGRAM TERMS AND CONDITIONS

## **Eligibility:**

1. The referral offer ("Offer") is available to any Simplii Financial client who has registered for the Simplii Financial Global Money Transfer service ("Referrer") who refers a friend or family member ("Friend") to Simplii Financial to send a Simplii Financial Global Money Transfer ("GMT") for the first time. The Offer is only offered to residents of Canada who have reached the age of majority in their province or territory of residence.

### **Offer Requirements:**

- 2. Subject to the limitations and restrictions set out in these terms, a cash referral bonus in an amount as set out <a href="here">here</a> ("Bonus") will be paid to each of the Referrer and the Friend if:
  - a) The Referrer uses the GMT referral link in Simplii Financial Online Banking to email the Offer to the Friend (no Bonus will be paid if the Friend is referred in any other manner); and
  - b) The Friend logs into Simplii Financial Online Banking, clicks the referral link and sends their first GMT in an amount not less than \$100 CDN (or the equivalent amount in a foreign currency) from a Simplii Financial personal bank account or line of credit account ("Account") held in their name within 30 days of receiving the email referral.

# **Bonus Payment:**

- 3. Bonuses will be paid into the Referee's and Friend's personal bank Accounts within 15 business days of the Friend's first GMT. If there are multiple Accounts in the Referee's or Friend's name, Simplii Financial will choose which Account will be credited.
- 4. If the Referrer or Friend does not have an Account, they must open one for Simplii Financial to deposit the Bonus. Bonuses will only be paid if the personal deposit or line of credit account open at the time the Bonus is due to be paid; it will not be paid in any other manner.

#### **Conditions:**

5. Each Referrer is limited to: (i) fifty (50) Bonuses within any twelve (12) month period; and (ii) two hundred fifty (250) lifetime Bonuses, except as may be agreed to in writing by Simplii Financial at its sole discretion.

- 6. Limit of one (1) Bonus paid to the Referrer per Friend and one (1) Bonus paid to the Friend, regardless of the number of Accounts in the Friend's name. The Friend must never have sent a GMT previously. This Offer cannot be combined with any other offer or rebate unless otherwise disclosed.

The Referrer agrees not to make any representations that they act on behalf of Simplii Financial, or are an employee, agent, intermediary or representative of Simplii Financial except to the extent the Referrer is a paid influencer or ambassador of Simplii Financial and, in such circumstances, only to the extent such representation is permitted under their applicable influencer or ambassador agreement. The Referrer agrees not to use paid advertising or a service of any kind to advertise, promote or share their email for referral unless expressly approved in writing by Simplii Financial for advertising purposes. The Offer can only be used for personal, non-commercial purposes.
- 9. The Bonus must be accepted as awarded and is not transferable or assignable. No Bonus substitutions will be permitted. The recipient of the Bonus is solely responsible for any tax consequences associated with their receipt thereof.
